#### **TERMS AND CONDITIONS**

Please read the Terms and Conditions carefully before confirming your registration. By completing your registration, you are agreeing to the terms and conditions laid out below.

#### 1. General

- a. MSAM Alif Walk ("Event") is an event organised by Permodalan Nasional Berhad (Registration No: 197801001190 (38218-X) ("Organizer") in conjunction with Minggu Saham Amanah Malaysia ("MSAM"), in accordance with the Terms and Conditions ("T&Cs") and all the terms and conditions stated hereunder in its website are applicable to all participants of the Event (hereinafter referred to as "Participant", "You" or "Your").
- b. By signing up or registering for the Event and/or submitting information to the Organizer through the online registration form, whether for the purpose of registering or otherwise, you signify that you have read, understood and agree to be bound by the T&Cs and the Privacy Policy as published on the website (https://www.pnb.com.my/msamalifwalk/index.html) in respect of the Organizer's collection, use, disclosure, and any other form of processing of your personal data.
- **c.** Participant, upon completion of the online registration form herein, agrees to be bound by these T&Cs.
- d. The Participant agrees to: (i) provide true, accurate, current and complete information about the Participant as per the online registration form ("Personal Information"); and (ii) The Organizer may contact the Participant from time to time by way of e-mail, or telephone call. Any notice sent to the e-mail address registered with the Organizer shall be deemed as received by the Participant.
- e. If the Participant provides any information that is untrue, inaccurate, not current and/or incomplete, and/or if the Organizer have grounds to suspect that such information is untrue, inaccurate, not current and/or incomplete, the Organizer may suspend or terminate the Participant's registration. The Organizer is also entitled to disqualify the Participant in the event of the discovery of any such untrue, inaccurate, current or incomplete information after the Event is completed and/or at any time of such discovery.
- f. The Organizer reserves the right (at its discretion) to modify or substitute any of the T&Cs from time to time as they deem fit. If there is ambiguity in any of these provisions, the Organizer shall be the authority to interpret and in so doing, the Organizer will endeavour to take into account the interests of all the affected Participants. Any amendments to the T&Cs will be updated on the event page without prior notice to the Participant.

- i. The Organizer reserves the right to limit and/or refuse entry to the Event without assigning any reason.

- **j.** The Organizer will not entertain nor be in any way responsible for any dispute arising from incomplete entry details.
- k. To the fullest extent permitted by law, the Organizer shall not be held liable for whatsoever loss or damages, whether directly or indirectly, howsoever arising in connection with the Event including the Participant's entry thereof. The Organizer shall not be liable for any default in respect of the Event due to any act of God, war, riot, strike, lockout, industrial action, fire, flood, drought, storm, endemic, pandemic, system and technical failure or any event beyond reasonable control of the Organizer.
- I. The T&C of the Event shall prevail over any provisions or representations contained in any promotional materials (including without limitation printed and electronic promotion materials) advertising the Event.

a. The Participant takes part in the Event at his or her own risk and shall be responsible for his or her own safety. - **a.** The Event is open to all Malaysians.

# 4. How to Register and Terms of Participation

## a. 5 KM Walk

- i. The Participant shall be required to register by physically attending and showing the National Registration Identification Card ("MyKad" or "MyKid") at the registration counter located at Setia Experience Center, Setia Fontaines, Bertam, Penang ("Event Site") on the morning of 30<sup>th</sup> September 2023 from 5:00 AM. No pre-registration is required.
- **ii.** The Participant will receive the Event t-shirt upon completion of the registration.
- **iii.** Registration will remain open until a total of six thousand (6,000) t-shirts have been handed out to the Participants. Any late registration WILL NOT be accepted or entertained.
- iv. Participant will ONLY be allowed to walk on the route starting at 7:30 AM ("5 KM Walk Flag Off Time").

- v. Participant MUST complete the walk before 9:30 AM or within one hundred twenty (120) minutes after the 5 KM Walk Flag Off Time. Participant agrees that if they are unable to complete the route by 9:30 AM they will be required to continue by walking on the roadside.
- **vi.** Participant MUST collect an orange wristband which will be given by the Organizer at Kilometer 4 of the Event route.
- vii. Participant will only be given goodie bags and light breakfast only upon completing the Event.

### b. 10 KM Run

- i. The registration period shall be indicated on website ( https://www.pnb.com.my/msamalifwalk/index.html) [hereinafter referred to as "Event Page"]. Any late registration will not be accepted or entertained.
- **ii.** Participant MUST register via the online registration form that is accessible from the Event Page ( https://www.pnb.com.my/msamalifwalk/index.html).
- **iii.** Participant MUST upload the proof of investment (screenshot of transaction slip) on any Amanah Saham Nasional Berhad ("ASNB") funds during online registration.
- iv. The online registration form shall remain open until the registration period has ended or a total of one thousand (1000) Participants have registered (whichever comes first).
- v. The Organizer reserves the right to extend or shorten the registration period.
- vi. Participant MUST collect their Event kit which includes an Event t-shirt and bib number at the Event Site on 29<sup>th</sup> September 2023, from 10:00 AM to 6:00 PM only.
- vii. Participant will be allowed to run on the route starting from 7:15 AM ("10 KM Run Flag Off Time").
- viii. Participant MUST complete the run by 9:15 AM or within one hundred twenty (120) minutes after the **10 KM Run Flag Off Time**. Participant agrees that if they are unable to complete the route by 9:15 AM, they will be required to continue by walking on the roadside.
- **ix.** Participant must obtain a blue wristband which will be given by the Organizer at Kilometer 6.5 of the route.
- **x.** Participant will be given a medal, goodie bags and light breakfast only upon completing the Event.

### 5. Cancellation and Disqualification

**a.** Participant are not allowed to transfer his or her Event entry to another party after his or her registration is confirmed, unless approved by the Organizer in writing.

**b.** The Organizer reserves the right at any time to disqualify any Participant who is refusing to adhere to the T&Cs and/or in any way behaving in a manner which the Organizer in their absolute discretion finds to be offensive or inappropriate.

### a. 5 KM Walk

i. All registered Participants of the Event in accordance with this T&Cs will be awarded with Event t-shirt, orange wristband, and only upon completion of the Event, the goodies bag which includes one (1) lucky draw number, sponsors' items, and light breakfast.

#### b. 10 KM Run

i. All registered Participants of the Event in accordance with this T&Cs will be awarded with Event t-shirt, blue wristband, and only upon completion of the Event the finisher medal, goodies bag which includes one (1) lucky draw number, sponsors' items, and a light breakfast.
